### TABLE & CHAIR RENTAL DISCLAIMER

All tables must be returned clean and **ANY** tape residue/gum, etc. must be completely removed or you will forfeit your deposit. **No exceptions.**

All chairs must be returned in clean condition as well, or you will forfeit your deposit. **No exceptions.** Any torn, stained or damaged chair pad will be charged for a pad replacement \$25.00 per pad.

### SOUND SYSTEM DISCLAIMER

Sound System will be returned in good working condition – all parts, components, etc and microphones, stands, etc. included.

Please initial here \_\_\_\_\_ to acknowledge that if the components are removed from the crate FOR ANY reason, you will forfeit \$100 of your security deposit. **No exceptions.**

### TENT RENTALS

Tent rental includes local delivery and set up and take down. Normal delivery fees apply to out of city limits.

All tents have been treated for water repellency but cannot be guaranteed to be absolutely waterproof. 6° has the right to charge a reasonable sum, as determined prior to installation for any 6° surface that requires drilling necessary to install tent. All necessary surface repairs shall be the responsibility of the renter. 6° will not be held responsible for damage to overhead or underground wires, irrigation systems, septic tanks or systems or any other underground or hidden obstruction. Renter will hold 6° harmless any damage(s) while at location.

1. This includes understanding that when deliveries are made, no matter who receives them on your behalf at your venue; that items are to be stacked and left in the same location as delivered. Chairs are to be stacked with the **pad** facing up 20 chairs high. **YOU WILL BE CHARGED FOR OUR TIME – MINIMUM OF ONE HOUR** if this requirement is not met. If items you rented came in boxes, items are to be returned in the same boxes, or you will be charged a replacement fee.
2. You shall be responsible for all associated replacement costs, including labor, cost to repair or replace items. If item(s) are not returned clean, a cleaning charge will be imposed and deducted from security deposit.
3. Linens are due back on the date following your event (excluding Sundays) – **NO EXCEPTIONS**. You are responsible for taking linens to a Federal Express location if return criteria is not met (you will need to pickup a call tag from 6° first).
